- 4.2. shareholders holding the Ordinary and A Preference Shares from a foreign jurisdiction might be subject to a different withholding tax rate;
- 4.3. the Dividends will be paid from retained earnings;
- 4.4. the gross Dividends amount to be used in determining the dividends tax is 13.809278 (thirteen point eight zero nine two seven eight) cents per Ordinary Share and 893 (eight hundred and ninety three) cents per A Preference Share where such a holder of the respective share is not exempted as such;
- 4.5. the dividends tax to be withheld by the Company is equal to 2.7618556 (two point seven six one eight five five six) cents per Ordinary Share and 178.6 (one hundred and seventy eight point six) cents per A Preference Share.
- 4.6. the net Dividends amount is 11.0474224 (eleven point zero four seven four two two four) cents per Ordinary Share and 714.4 (seven hundred and fourteen point four) cents per A Preference Share.
