#### INTRODUCTION

Ordinary shareholders are referred to the Section 60 resolution approval dated 6 April 2024 authorising the Company to proceed with the subdivision of (i) the current authorised ordinary share capital of the Company comprising of 2,000,000 ordinary no par value shares into 100,000,000 ordinary no par value shares, and (ii) the current issued ordinary share capital of the Company comprising 2,000,000 ordinary no par value shares into 100,000,000 ordinary no par value shares (and the MOI amended accordingly, approved by CIPC dated 20 May 2024).

#### SHARE-DIVISION

The Company has decided to do a share subdivision or split of the Gaia Renewables 1 Ordinary Share at a ratio of 50 for every 1 security held, and a new security with the share code 4AGR1O and an ISIN of ZAE400000259 will be issued and listed on Monday, 21 October 2024.

The subdivision of the current authorised and issued ordinary share capital of the Company comprising 2,000,000 (two million) ordinary no par value shares by a factor of 50, such that the Company shall have a total authorised and issued ordinary share capital of 100,000,000 (one hundred million) ordinary no par value shares.

The effect of the share split will not result in any fractional entitlements.

There are no certificated holdings.

All Ordinary Shares will increase by a factor of 50 for each security held, and the net asset value of the Company will be the same as of the close of the Last day of trade; therefore, the opening price per unit on the listing date of the Ordinary Shares on Monday, 21 October 2024 will be reduced by the same ratio.
